**PUBLIC HEARING  
2023-2024 BUDGET /  
GENERAL FUND**

Superintendent Johnson provided a budget presentation which reviewed revenue sources and estimated expenditures for the 2023-24 general fund operational budget. Revenues reflect an estimated foundation grant allocation of \$9,600 (\$450 increase per latest information regarding State funding). All federal grant monies are unconfirmed and estimated at this time. Limited ESSER funds are included in this budget with corresponding expenditures. Fall student enrollment projections are estimated at 257, based on February 2023 student count and preliminary kindergarten enrollments. Contract agreements are not settled with the Teachers Education Association, accordingly wage increases are included for both unions in the preliminary budget and insurances are projected to be the same plans with the hard cap for all staff. Projected expenditures for discretionary purchases have been adjusted. Projected expenditures are anticipated to exceed projected revenues.

No public comment was made following the review.


